

GRAND JURY RETURNS 24 INDICTMENTS

The Barren County Grand Jury met last week and returned 24 indictments.

Joshua D. Wagner 22 of Glasgow was charged with Intimidating a Participant in the Legal Process, and Terroristic Threatening, 3rd degree.

Timothy L. Harris 22 of Lebanon, Tennessee was charged with Promoting Contraband, 1st degree; Theft by Unlawful Taking, under \$500; Possession of Marijuana and Alcohol Intoxication in a Public Place, 1st and 2nd Offenses.

Sara Jane Kuzminski 26 of Hartsville, Tennessee was charged with Promoting Contraband, 1st degree; Possession of Marijuana; Operating a Motor Vehicle While under the Influence of Alcohol which impairs one's driving ability, 1st Offense and Reckless Driving.

Michael Alton Bruton 39 of Glasgow was charged with Unlawful Possession of Methamphetamine Precursor, 2nd Offense; Possession of a Controlled Substance, Methamphetamine, 1st degree, 2nd offense; Possession of Drug Paraphernalia; No or Expired Registration Plates and Persistent Felony Offender, 1st Offense.
