

## SEVERAL DRUG AND FIREARM ARRESTS FROM THE PAST FEW DAYS

A GLASGOW MAN WAS ARRESTED APRIL 15<sup>TH</sup> AROUND 2:30 FOR DRUG CHARGES. THE BARREN EDMONSON ALLEN DRUG TASK FORCE ARRESTED 30 YEAR OLD, DENNIS DECKER OF GLASGOW ON TRAFFICKING METHAMPHETAMINE CHARGES. DURING THE ARREST 6 GRAMS OF CRYSTAL METHAMPHETAMINE WAS SEIZED FROM DECKER. THE ARREST WAS MADE ON KY 68-80 WEST OF GLASGOW. DECKER WAS LODGED IN THE BARREN COUNTY JAIL. DRUG TASK FORCE WAS ASSISTED BY THE BARREN COUNTY SHERIFF'S DEPARTMENT.

A GLASGOW WOMAN WAS ARRESTED APRIL 17<sup>TH</sup> ON NEWMAN STREET IN GLASGOW. 71 YEAR OLD, MATTIE TATHAM OF GLASGOW WAS ARRESTED AT HER HOME FOR RECEIVE STOLEN PROPERTY AND POSSESSION OF A FIREARM BY A CONVICTED FELON. PROBATION AND PAROLE WENT TO THE HOME. UPON ARRIVAL TATHAM GAVE PERMISSION TO SEARCH THE RESIDENCE. DURING THE SEARCH A HANDGUN WAS FOUND IN TATHAM'S BEDROOM. UPON INVESTIGATION THE FIREARM HAD BEEN STOLEN FROM CALIFORNIA IN THE 1980'S. TATHAM STATED SHE GOT THE GUN FROM A FAMILY MEMBER ALONG TIME AGO. SHE ALSO STATED SHE HAD A FAMILY MEMBER MOVE FROM CALIFORNIA TO KENTUCKY WHICH WAS NEAR THE TIME FRAME THAT THE WEAPON WAS STOLEN. TATHAM WAS ARRESTED AND LODGED IN THE BARREN COUNTY JAIL. THE PROBATION AND PAROLE WERE ASSISTED BY SGT. BURTON OF THE GLASGOW POLICE DEPARTMENT.

A LOUISVILLE MAN WAS ARRESTED AT A CAVE CITY MOTEL APRIL 16<sup>TH</sup> AROUND 7:15. THE BARREN EDMONSON ALLEN DRUG TASK FORCE ARRESTED 42 YEAR OLD, SEAN CHARLES HAYES OF LOUISVILLE WITH TRAFFICKING METHAMPHATINE CHARGES. DURING THE ARREST 29 GRAMS OF CRYSTAL METHAMPHETAMINE WAS SEIZED, ALONG WITH 1700 DOLLARS IN CASH. THE ARREST WAS MADE IN THE PARKING LOT OF THE SUPER 8 MOTEL IN CAVE CITY. THE DRUG TASK FORCE WAS ASSISTED BY THE ATF, BARREN COUNTY SHERIFF'S DEPARTMENT AND THE CAVE CITY POLICE DEPARTMENT. HAYES WAS LODGED IN THE BARREN COUNTY JAIL.

THE BOWLING GREEN WARREN COUNTY DRUG TASK FORCE ARRESTED A BOWLING GREEN MAN APRIL 16<sup>TH</sup> AROUND 7:52. THE DRUG TASK FORCE ALONG WITH THE WARREN COUNTY SHERIFF'S DEPARTMENT WERE DOING AN UNDERCOVER DRUG PURCHASE IN THE PARKING LOT OF MEL BROWNING STREET. 34 YEAR OLD, JEREMY D. CLINE OF BOWLING GREEN WAS ARRESTED WHEN CONFRONTED BY A UNIFORM SHERIFF'S DEPUTY AND THE DRUG TASK FORCE DETECTIVE. HE DID RESIST ARREST AND WAS TASED WITH NO FURTHER RESISTANCE. HE WAS CHARGED WITH TRAFFICKING IN A CONTROLLED SUBSTANCE 1<sup>ST</sup> DEGREE 3 COUNTS, RESISTING ARREST, PROBATION VIOLATION AND DUI. 300 DOLLARS FROM THE DRUG PURCHASE A CELL PHONE TASER AND A 2005 NISSAN FRONTIER TRUCK WERE SEIZED FOLLOWING THE ARREST. CLINE WAS LODGED IN THE WARREN COUNTY JAIL PENDING ARRAIGNMENT IN WARREN DISTRICT COURT.

THE BOWLING GREEN WARREN COUNTY DRUG TASK FORCE ARRESTED A BOWLING GREEN MAN APRIL 17<sup>TH</sup> AROUND 6:30. DETECTIVES OBTAINED SUFFICIENT INFORMATION TO OBTAIN A SEARCH WARRANT ON A GARAGE BUILDING LOCATED BEHIND CEMETERY ROAD IN BOWLING GREEN. DURING THE SEARCH APPROXIMATELY 10 THOUSAND DOLLARS IN TOOLS STOLEN FROM THE WARREN COUNTY ROAD DEPARTMENT WERE RECOVERED ALONG WITH OTHER PROPERTY STOLEN FROM EWING PROPERTIES IN BOWLING GREEN. ALL INGREDIENTS WERE TO MANUFACTURE METH ALONG WITH EVIDENCE OF PRIOR METH LAB ACTIVITY. 35 YEAR OLD, MILTON BRADFIELD WAS ARRESTED AFTER THE SEARCH AND CHARGED WITH MANUFACTURING METH, UNLAWFUL POSSESSION OF A METH PRECURSOR, AND RECEIVING STOLEN PROPERTY OVER 500 DOLLARS 2 COUNTS. HE WAS LODGED IN THE WARREN COUNTY REGIONAL JAIL PENDING ARRAIGNMENT IN WARREN DISTRICT COURT. THE DRUG TASK FORCE WAS ASSISTED BY THE KSP BOWLING GREEN POST.
