Flippin Is Hit by Wind Storm. Considerable damage is reported from various sections as a result of the severe wind and rain storm Tuesday night. Unconfirmed reports from the Flippin section would indicate that that section may have borne the brunt of the sudden squall when a severe windstorm, of near cyclonic velocity, struck. A barn belonging to O. B. Downing was reportedly destroyed, while another was damaged, though stock in the barn was unhurt. Several houses in the section were reported to be unroofed, and several telephone poles on the Glasgow-Edmonton lines were downed.

Route 80 Planned for Top This Fall. Route 80 from Glasgow to Somerset will be a fully-surfaced road by winter time, according to the present plans announced this week. This important East-West artery is now being surfaced from Russell Springs to Columbia, and the plan now is to continue to Edmonton, passing through Gradyville, Weed, and Red Lick. If the entire gap is completed, about 20 miles would be included in this project.
